COVID-19 - VOGO announces CE marking of EasyCov

VOGO (ISIN: FR0011532225 - Ticker: ALVGO) is announcing the CE marking approval of EasyCov, a saliva test for SARS-COV-2, with a view to placing it on the market.

Developed by the consortium formed by the biotechnology company SKILLCELL, a subsidiary of the ALCEN group, the CNRS SYS2DIAG laboratory (CNRS/ALCEN) and the company VOGO, EasyCov allows diagnosis by a medical biologist based on a saliva sample in under one hour in a medical laboratory or in field.

This major innovation, combining the EasyCov test produced by FIRALIS and the digital solution developed by VOGO which integrates the automatic analysis of the results analysis by way of a colorimetric reading "EasyCov Reader" and the digital portal that is interoperable with all the healthcare information systems, will ensure rapid localised mass testing in situations such as sports competitions or checks for transport or within companies. EasyCov offers multiple advantages compared to the mechanisms currently available: rapid, painless, usable anywhere and suitable for mass testing.

As part of this partnership and given its technological contribution to the EasyCov development program, VOGO received a payment of approximately €200k from the consortium and a subsidy of €200k from la Region Occitanie. With the commercialization of EasyCov tests now permitted, VOGO will also receive royalties from net sales of kits. These royalties will start at 7% of the turnover before tax and will vary according to the sales levels reached. For sales exceeding 500,000 kits at a catalogue price of 20 euros (before tax), VOGO will receive royalties of 3.5% of turnover before tax.
